Young people

Young people have always been risk-takers

"I see no hope for the future of our people, for certainly all youth are reckless beyond words" Hesiod (700 bc)

"The young are permanently in a state resembling intoxication." Aristotle (300 bc)

"The over-involvement of young, and male, road users is one of the largest and most consistently observed phenomena in traffic throughout the world. It is so robust that it is almost like a law of nature." Leonard Evans (1991)

Young people (15-30)

- 140,000 young people killed in collisions in the EU-27 between 2001 and 2010
- 9,150 killed in 2010
- A reduction of 44% compared to 2001
- 81% of those are male
- Young people represent 20% of the population but 30% of all road deaths
- No official definition of young people. At age 15:
 - Travel choices no longer dictated by parents
 - End of compulsory education
 - In many countries first possibility to drive a moped
 - Legally responsible



Higher risks for all young users

Relative injury risk of road users aged 18-24 compared to safest age group for each type of road user (Norwegian data)



A biological basis for high risk?



Severe collisions/ million pop. Arrest /1000 pop.

Testosterone level

- Research suggests that the high involvement of young drivers in accidents may in part have a biological basis (high testosterone levels; higher cognitive functions of the brain not fully developed until the age of about 25)
- Training is a double-edged sword: it is necessary, but it may give drivers
 an excessive confidence in their driving skills

Young people at higher risk than the rest of the population

Latvia, Spain, France

- Police enforcement and stricter sanctions for all
- Penalty point system for all drivers (stricter for novice drivers)
- Lower alcohol limit for novice drivers
- Education and campaigns (BOB, ...)
- Raise of the minimum age for driving a moped (Spain)
- Fully automated safety camera system = The measure with the highest impact also for young people



Young people: a male problem

Young drivers an important cause for concern

37% of road deaths in EU happen in a collision involving a young driver (18-25)





ETSC Recommendations

- Continue to research the causes of young, novice driver risk with a view to designing more effective countermeasures.
- Ensure effective legislation and enforcement.
- Improve training and licensing systems.
- Ensure high levels of experience, via accompanied driving, prior to licensing for solo driving.
- Reduce exposure to risk immediately following licensing for solo driving.
- Provide appropriate incentives and disincentives, e.g. stricter demerit point systems.
